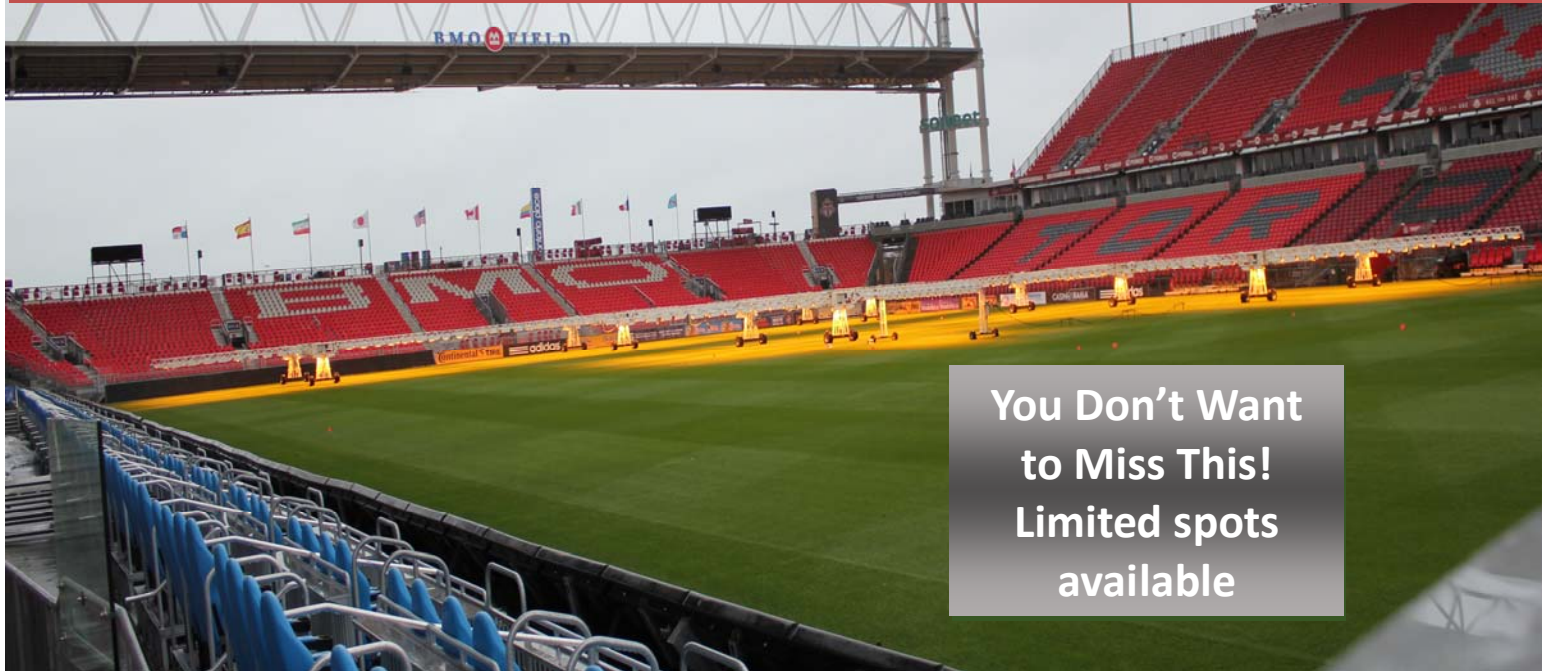

A hybrid grass or reinforced natural grass is created by combining natural grass with synthetic reinforcing fibers by injecting fibers uniformly over the entire pitch. Such fields are used for stadium pitches, training pitches and for a variety of sports fields including football, baseball, soccer, lacrosse, softball, field-hockey and multi-purpose sports fields.

This is a technologically advanced turf system which combines the very best qualities of both synthetic and natural surfaces. The result is a 95% natural pitch that gives you more playing hours and faster pitch recovery. It provides pitches that can stand up to all the challenges provided by busy stadia, competitive sports activity and environmental conditions.
